2018 Annual Meeting

Recap of 2017-2018:

The Mississippi MRPC continued to learn and get to know our funding partner- the MDA- and to see how to best let them know what our Commission does, and how we benefit the State. They are appreciative of what we have done, and have funded us as requested for the last 2 years (no cuts).

Next, we identified 2 new interpretive centers for MS- Leland, MS for the Mississippi Wildlife Museum and Grand Gulf in Port Gibson. The process took place to meet with them, have them apply, and those request have been submitted for approval to the Commission

Once we were appointed to host the 2019 semi-annual meeting, we began work on preparing for that meeting, and spent most of the rest of fiscal 2018 working on that.
