- I. 2020 Marketing Plan
 - COVID-19 Messaging Update: states provided updates on the status of travel and overall cases in their region. Overall, travel is still fairly restrictive in each state. WI shared travelers are looking for information on steps taken to address safety and choose not to stop if they can't find information.
 - Interpretive Centers Campaign: IC continue to be closed in many areas or with limited staffing and hours. Marketing Committee will continue to monitor their progress to give support.
 - Summer Flavors Campaign: As cases throughout the 10-states began to rise, NO held the campaign to see if travel restrictions would be put in place. NO hopes to launch the campaign in the next few weeks based on current travel conditions.
 - Drive the Great River Road Month: NO plans to launch campaign at scheduled time but will continue to monitor travel conditions and restrictions and will seek input from committee as the dates approach. AR recommended adding geocaching to the mix with the campaign. MN shared the outdoor recreation webinar attended and overwhelming interest in those activities. NO concurred and will be certain to include outdoor recreation elements into the campaign language.
- II. All American Road applications: Reported back to committee final number of applications submitted and again thanked LA for supporting the efforts.
- III. TRIP legislation and US Travel toolkit: NO reviewed US Travel toolkit as an option to share to their commissions with messaging updates for businesses. MN reviewed TRIP legislation and shared NO and Board and staying updated for possible participation.
