


I am writing this letter in support of designing the "Great River Road" an "All-American Road."

WHEREAS, the "Reviving America's Scenic Byways Act of 2019" reopened applications for new All-American Road and National Scenic Byway designations to be submitted to the Federal Highway Administration, United States Department of Transportation by May 15, 2020; and

WHEREAS, since 1938 the ten-state national Mississippi River Parkway Commission preserves, promotes and enhances the Great River Road National Scenic Byway benefitting communities and travelers along the Mississippi River. Between 2000 and 2009 the ten Mississippi River states successfully achieved National Scenic Byway designation; and

WHEREAS, the Great River Road meets All-American Road designation criteria, possessing intrinsic resources that are of national significance and is a destination and reason for travel unto itself. In December 2018 the ten-state national Mississippi River Parkway Commission adopted a Ten-State Great River Road Corridor Management Plan that compliments and leverages state-specific corridor management plans; and



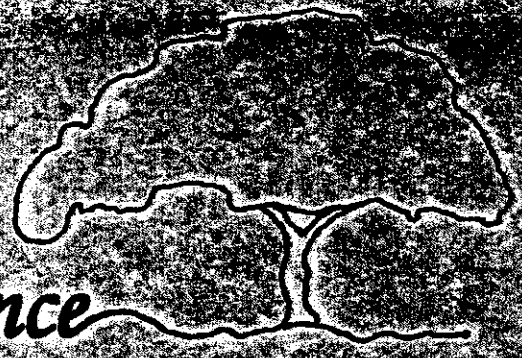

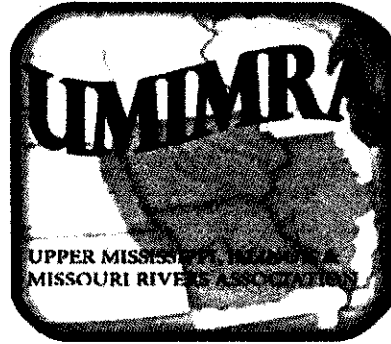

Since 1938 the ten-state national Mississippi River Parkway Commission has worked to preserve, promote and enhance the Great River Road National Scenic Byway benefiting communities and travelers along the Mississippi River. The Great River Road meets All-American Road designation criteria, possessing many and varied intrinsic resources that are of national significance. As *the* official access to the Mississippi River through ten states since the time pleasure driving began, the Great River Road is an iconic destination and reason for travel unto itself for many, whether for a few hours or a few months. We applaud that all ten Great River Road states are seeking All-American Road designation from the Federal Highway Administration and we support Iowa and its nine partner states in this endeavor.

The Great River Road has importance for all communities along the river – from small and rural, to large and metropolitan - as an artery of stewardship, storytelling, tourism and commerce along the Mississippi River benefiting visitors and residents alike. In Iowa, the Great River Road spans 341 miles, 10 counties, and many communities, guided by a Corridor Management Plan that meets FHWA requirements for All-American Road designation.
