- **Financial Update** Motion to approve but notation to carry money in money market instead of higher balance in checking account. Motion to approve by WI. Second by KY. Motion carried.
- All-American Road Designation (AARD) –Discussion occurred to reach out to state agencies and thank them for their participation and let them know applications were submitted. This will be a state-by-state decision to communicate where states see fit.
- **MRPCmembers.com Website** The site has been a repository of information with current work, a resource for preparing for meetings and serving as a back office for committees, the board and state commissions. We will look to put resources behind it in the coming year's budget.
- **Great American Outdoors Act** –John Anfinson shared information about the Great American Outdoors Act, signed by the President on August 4. It includes \$1.9 billion per year for 5 years to provide needed maintenance for critical facilities and infrastructure in our national parks, forests, refuges, and recreation areas. MRPC will not see that money but every state must set up a s-corp and will accept applications that fit the plan. How can we tap into it? Go to our GRR communities and see if there are opportunities that fit. There is a 50 percent match required.
