Minutes

I. Call to order and introductions

II. Kentucky Great River Road NSB Signing Project Update

Greg and Mike provided an update on the project plan development which is moving along as planned and is currently 90% complete. KDOT will provide the posts and hardware, as well as most of the installation. The hoops and process required by Federal funds have been a challenge they are also meeting. Advice was sought regarding America's Byways sign colors allowed and used by others. The group referenced the MUTCD which indicates black and white or red, white and blue are allowed. The consultant wanted to consider brown and white.

III. Survey Of Cross-River State-to-State Routes

Mary and John shared that Iowa is preparing for a scenic byway route revision. In preparation for that the Iowa MRPC is considering including Great River Road spurs from the current route which parallels the river to each river crossing bridge at approximately the state line. They sought advice including if any other state has spurs to the river bridges, if any state has signs directing to the GRR from the river bridges.

No other state has GRR spurs to the river crossings, although some do sign from one state to the other (MN to WI in MN at US 10 and US 61). MO showed online how the river is at times many miles away from the river and not the first road or even major road one encounters when traveling from a river crossing. IL does sign to the GRR from Interstates.

V. Other GRR projects ongoing or planned

WI – DOT 8-20-2014 press release announcing "Upper Mississippi River receives Federal Marine Corridor Highway designation." (attached) No one present had heard this news yet affecting St. Louis to Minneapolis to be known as M-35. All asked for the press release to be a part of the minutes for further use once back in the office.

AR- Dr. Ruth Hawkins is working with local communities on a project related to the Sultana, a Mississippi River side-wheel steamboat that exploded on April 27, 1865 in the greatest maritime disaster in United States history. An estimated 1,800 died as a result.

IL – Denise Todd is a DOT staff member recently assigned as the state byway coordinator.

MO - I-70 reconstruction near the St. Louis Arch is underway and will result in a cover over the open Interstate better connecting the historic and park properties in the area.

Also The Stan Musial Veterans Memorial Bridge (known as the New Mississippi River Bridge until its formal naming in 2013 and informally known as the "Stan Span") is a bridge across the Mississippi River between St. Clair County, Illinois, and the city of St. Louis, Missouri. Built between April 19, 2010, and July 2013, the bridge opened on February 9, 2014. The cable-stayed bridge has a main span of 1,500 feet.

IA: The IaMRPC is more than half way to completion of a Corridor Management Plan update. Dave shared results from visitor and resident surveys, public meeting input and route and amenity analysis. Very impressive process and results. Other outcomes include discussions with DOT regarding utilizing Google maps for GRR mapping as a better map is one area the survey reveal a need for improvement.
