## **WIMRPC Membership, Committees:**

## Membership

The WIMRPC operates under Wisconsin State Statute 14.85 which specifies membership to consist of one representative appointed by the Governor from each of the eight counties bordering the Mississippi River along with two State Senators and two State Representatives. The Statute provides ex officio membership of the State Departments of Transportation, Natural Resources, Tourism, Commerce and State Historical Society.

Sherry Quamme (Commissioner from Crawford County) was elected for a two year term as WIMRPC Chairperson. Other elected officers are: Jean Galasinski (Trempealeau County) Vice Chair, Alan Lorenz (La Crosse County), Secretary. The Treasurer seat is vacant and is fulfilled by shared duties between the three members of the Executive Committee for the present time.

## **Meeting Minutes**

WIMRPC convened four quarterly meeting during this reporting period. Minutes of the meetings are appended to this report. They are also provided routinely to the National MRPC office and to 75 other parties.

## **Budget**

The source of funds for the WIMRPC is derived primarily from contributions from the 8 represented counties, Department of Transportation, Department of Tourism and from National Scenic Byways Grants. Income

from sale of Ads for the 2017 Wisconsin Great River Road Visitor Guide is a major source of income along with financial support from three grants. There are also contributions from some Tourism Councils of the region. Expenditures are primarily for Marketing and Promotion of the Wisconsin Great River Road National Scenic Byway, Sustainability/financial support, Partnership & Outreach.

## **Accomplishments:**

## **Partnership and Outreach**

- Completed steps to found the Friends of the Wisconsin Great River Road National Scenic Byway and established the new organization as a 501 c 3 IRS status entity.
- Approved Bylaws for the Wisconsin Friends of the GRRNSB and approved on 8/5/16
- Friends of the Wisconsin Great River Road had an educational booth at the March 2017 Wisconsin Governor's Conference on Tourism to promote both the Friends Organization, the WIMRPC and the Wisconsin Great River Road.
- Friends of the Wisconsin Great River Road took out an ad in the 2017 Wisconsin Great River Road Visitor Guide to promote the Wisconsin GRRNSB and invite new memberships.
- Connected with 68 Adopt a Highway groups of the Wisconsin GRRNSB to support highway clean up twice per year, with assistance of the WI DOT.

- Continued discussions with the Mississippi River Regional Plan Commission staff regarding assistance to the WIMRPC, working on Tourism as economic development. Also researching Grant options, ideas, and potential new funding sources.
- Exhibit at State Capitol Rotunda May 30 June 5 for education regarding Wi GRRNSB which coincided with June Dairy Month and promotion of Agri Tourism.
- Created a Work plan for 2017-18 to schedule and conduct meetings with stakeholders "Spring Board" meetings to provide education regarding WIMRPC, WI GRRNSB and officially launch Friends of the WI GRR. Will enlist the assistance of retired WI DOT Byways Coordinator Jane Carrola for this.

## **Financial Stability/Long Term Sustainability**

- August 5, 2016 Established a plan to conduct meetings with legislators starting in January, 2017.
   Assistance from all 4 legislator commissioners was offered and accepted.
- Schedule meeting with partner Mississippi River Regional Plan Commission to identify potential Grants that could be considered, applied for by WIMRPC to support the work plan.
- Determine means for funding a paid staff person to facilitate the WIMRPC
- Explore feasibility of updating SS 14.85 to identify current State Agencies who are to support the WIMRPC and determine what other options there are for added State Funding such as a line item in the Bi-Annual State Budget

## **Building and Maintaining a Sustainable Organization/NSB**

- Education Session for WIMRPC on NSB projects Potosi Brewery and Museum and the Genoa Fish Hatchery project with US Fish & Wildlife.
- Provided information to WIDOT on scenic easement infractions on the WIGRRNSB which resulted in actions to address these issues. This work continues as issues are not resolved.
- Participated in the ongoing development of the Geo-Tourism Website as part of the MRPC agenda.
- Continued to monitor use of remediation funds specific to CAP X 2020
- Through the efforts of the Executive Committee and Commission, worked to address financial management issues by converting financial records to Quick Books which is a financial management software system. This work continues.
- Utilizing the services of an accounting firm to update financial records.
- With assistance of Commissioner Senator Howard Marklein, developed financial policies for business operations.
- Contracted with Mississippi River Regional Plan Commission staff to develop the WIMRPC Handbook for Commissioners and Committees and to develop an updated Corridor Management Plan utilizing the Building and Maintaining a Sustainable Organization Grant.
- Communicated scenic easement concerts to the US Army Corps of Engineers regarding repository for dredged materials from Pool 4 which the COE proposed to be located on Hwy 35, the WI GRRNSB. This was done by their August 25, 2017 Public Comment deadline.
- Drafting a policy on repository and records retention for the WIMRPC.

## **Promotion and Marketing**

- The Wisconsin Dept. of Tourism has invested \$35,000 in direct marketing investment to promote and market the Wisconsin Great River Road Region as of 8/1/17. This continues to be a strong, valued and important relationship for the benefit of all parties.
- Publication of the 2017 Wisconsin GRRNSB Visitor Guide and distribution of 50,000 copies across the region.
- Printing of the 2017 Visitor Guide including selection printing vendor La Crosse Graphics and Kristen
  Mitchell Design for the editing again resulted in a positive cash flow from the project. A sales person was
  added to work on commission as a way to sell additional ads in the VG.
- Selected La Crosse Graphics and Kristen Mitchell Design as the venders for the 2018 Visitor Guide is expected to result in a positive cash flow again from this project. Contracts were established with 2 sales people to work on commission for the sale of the 2018 VG ads. This is expected to increase the number of ads in areas that have been under represented and will alleviate some of the workload for the volunteer WIMRPC and the volunteer Promotion & Marketing Committee. Quick Books accounting system was implemented in 2016 to help with the business management of this project and that continues to be successful. 100% of the ad accounts were paid.
- Contracted with Sleeping Giant Studio, a La Crosse, WI company, to develop a new website and move the
  hosting to a new vender. Revenue from the 2016-17 Visitor Guide projects will help fund this project and
  it is due to "go live" by Sept. 1 2017.
- Exhibitor at the Minneapolis Home & Garden Show
- Wisconsin Governor's Conference on Tourism partnered with Friends of the WI Great River Road as an exhibitor at Market Place.
- Milwaukee Wheel & Sprocket Bike Show with Wisconsin Dept. of Tourism
- June Dairy Breakfast exhibits 8 Counties
- Wisconsin State Fair (With Wisconsin Dept. of Tourism)
- September Drive the Great River Road Month promotion
- Great River Road Festival Stonefield Historic Site Cassville, WI
- AgriTourism Promotion
- Maintained an increasingly popular social media campaign for the WI GRRNSB. Excellent gains in engagement. (Report Attached)
- Invested \$3035 for an ad in the May/June 2017 issue of Midwest Living as part of the WI Dept. of Tourism Co-op advertising opportunity. As of Sept. 2017, over 1000 requests for information and 2017 Visitor Guides had been fulfilled. Strong consideration to do this again in 2018.

## **History/Education**

- Completed inventory at all Interpretive Centers
- Distributed 3 cases of the Corp of Engineers publication "Our Mississippi", to elementary and middle schools of the region. (This is a continuing effort which was started in 2014).
- Intrinsic Qualities rack cards were distributed with display units to each of the WI GRR Interpretive
  Centers. These will also be distributed in sets to Elementary and Middle schools of the WI GRRNSB who
  receive "Our Mississippi" publications.

#### **Technical**

- Provided assistance to the Partnership and Outreach Committee regarding Friends of the WI GRRNSB design and implementation
- Contracted with partner organization Mississippi River Regional Plan Commission to create the WIMRPC Handbook as part of the Building and Maintaining a Sustainable Organization Grant. Distribution will occur September 2017. Electronic files will be shared with all 10 GRR States.
- Contracted with partner organization Mississippi River Regional Plan Commission (MRRPC) to assist with updating the WI Corridor Management Plan – Strategic Plan as part of the Building and Maintaining a Sustainable Organization Grant.
- In collaboration with MRRPC, contracted with Corridor Solutions, to do an Online Stakeholder survey and assist with leading the Strategic Plan/CMP update to be completed by Spring 2018.

## **Executive Committee**

- Developed and approved an updated draft of the WIMRPC Bylaws for consideration which includes allowing legislative members to identify a lead staff person to attend Commission meetings and hold the proxy for the respective Legislator Commissioner.
- Worked diligently on operations, business and financial activities with the support /guidance of WI DOT advisor Jane Carrola
- Provided ongoing support to all committees including the Partnership and Outreach Committee for the implementation of the Friends of the Wisconsin Great River Road efforts.
- Planning for the Fall 2017 CMP/Strategic Action Planning meeting to update the WI CMP.



## **MINUTES**

WIMRPC Meeting November 11, 2016

State Office Building

La Crosse, Wisconsin

## 1, CALL TO ORDER:

Chair Quamme called the meeting to order at 9:35 a.m. and asked those in attendance to introduce themselves so everyone would know who was there.

## 2. ROLL CALL:

Commissioners present: Representative Lee Nerison; ,Sherry Quamme; Jean Galasinski; Al Lorenz; Dennis Donath, Dave Smith, Katy Prange, Chief of Staff for Senator Marklein

Commissioners excused: Senator Kathleen Vinehout, Representative Chris Danou, Tom Vondrum, Bob Miller

Others present: WIMRPC Promotion Committee members: Amy Gabay (Chair), Jeanne Rutter and Mary Rae representing Karen Dahl,, Karrie, Jackelen, (Aide to U.S. Representative Ron Kind), Technical Committee members Mike Rewey, Bob Fisher, Jennifer Kuderer, Ric Ahern

Others excused: Drew Nussbaum, Department of Tourism Regional Specialist,

Quamme announced that a Quorum was present.

## 3. MINUTES:

The minutes of August 5, 2016 were discussed and approved. MSC Galasinski/Donath

## 4. CHAIR REPORT

Possible dates for the WIMRPC 2017 Quarterly meetings were reviewed and approved as: January 13<sup>th</sup>, April 21<sup>st</sup>, August 11<sup>th</sup>, and November 10<sup>th</sup>. Galasinski will be in contact with WIDOT to make room reservations for these meetings.

.Quamme reported:

- \*\* Our Commission members have donated \$250 towards a scholarship fund in the name of Patrick Reinsma through Waukesha Technical College.
- \*\*The WIMRPC 2015-2016 Annual Report was prepared by Quamme for the Annual MRPC Meeting and distributed to Commission Members and other interested parties.
- \*\*The MRPC had requested nominees for Distinguished Service Award, Honorary Membership, and nominees for new Interpretive Centers. Bob Miller was nominated for the Distinguished Service Award by the WIMRPC and was presented with that Award in Natchez. Congratulations to Bob—well deserved.

## 5. TREASURERS REPORT

Acting Co-Treasurer Quamme Quamme reported that there is presently (11/3/16) a balance of \$34,252.35 in the Commission's Checking Account. This amount includes revenue from past and present Visitor Guide sales and WIMRPC Reserve funds.

Quamme then reviewed a number of QuickBooks Reports ----Balance Sheet of November 3, 2016, Profit and Loss January through November 2016 and the Customer Balance Summary.

There are still a number of venders who are in 'Accounts Receivable' for the 2015 Visitor Guide Ads. Notices have been sent to those businesses. These accounts are expected to be paid in the near future.

Quamme them presented a draft Financial Policy developed by Sen. Marklein and Quamme. Copy attached

MSC Galasinski/ Donath to accept the Treasurers Report and approve the new Financial Policy

An audit of the Commission's financial records will be delayed until a Commissioner is appointed to assist Tom Vondrum.

#### 6. REAPPOINTMENT UPDATE

Quamme reported that there are several possible candidates to replace Maynard Cox as Vernon County Commissioner. We should know more by our January 13<sup>th</sup> Commission Meeting.

## 7. WIDOT UPDATE

Due to a scheduling problem, this Report was deferred until the January 13th, 2017 Commission meeting.

#### 8. TOURISM UPDATE

Drew Nussbaum has been reassigned to the SW Wisconsin Region to replace Patrick Reinsma. The replacement for Drew is Julie Fox of Siren in the Northwest Wisconsin Region.

Quamme said that a meeting with Department of Tourism's Deputy Secretary Sarah Klavas has been scheduled for November 16<sup>th</sup> in Madison. A detailed Report of the Commission's 2016 "marketing activities, 2017 Goals and funding needs is being prepared by the Marketing and Promotion Committee for this meeting.. Tourism has asked the Commission to partner with them on a Midwest Living Ad in the Spring Edition. MSC Smith/Lorenz to allocate \$3000 for this joint marketing ad to promote the GRRNSB.

Tourism provided over \$30,000 in promotion/marketing for the GRRNSB corridor in 2016.

The 2018 Superbowl will be hosted by the Vikings in Minneapolis. Judy Berg, River Falls Chamber of Commerce & Tourism, member of Promotion & Marketing serves on their Volunteer Committee for Events and is recommending our Promotion & Marketing Committee be involved to promote the WI GRRNSB, communities and events to draw visitors to our region. Rooms are being reserved as far east as Eau Claire. Networking to research the possibilities has started and more information will follow.

A Tourism Scholarship to the Governor's Annual Tourism Conference is being developed by the SW Wisconsin Area Chambers of Commerce. .Each County Board is being asked for a donation. MSC Donath/Smith to approve a donation of \$300 from the Commission funds. The Director of the PduC Chamber Bob Moses is heading up this scholarship drive.

## .9. LEGISLATIVE UPDATE, INPUT

Representative Danou was not re-elected in November so a new Democrat Representative will need to be recommended by the Democratic Caucus and appointed by the Governor. Quamme will monitor to assure this appointment is made in a timely manner.

Representative Nerison reported that the Railroad Commissioner has identified a number of locations when additional Public Crossings could be constructed to help the public gain access the River and public lands. It was the general consensus that these additional crossings would be very expensive to construct and not provide sufficient access for the public. Public Meetings concerning the trespass law will be scheduled in the future.

Fisher reported that there is an active Passenger Rail group called "All aboard Wisconsin" whose goal is: "Get more rail passengers to more places in Wisconsin with convenient connections to local and regional public transit including Amtrak.

John Medinger, Aide to Senator Baldwin reported that the Senator has requested a review of the Railroad "trespass law" by the Federal Legislative Research Council and there is an early determination that the Railroad does not have the legal authority to inforce this Law.

Medinger investigated to determine see who has the legal authority to write tickets and make arrests concerning the trespass law. Here is his response:

"Most of the laws/regulations come from the State level, this one included. Railroads hire their own police officers that are commissioned by the State and issue citations when the State Law is broken. Any fines issues are paid to the State and appeals go through State Court".

Prange reported that Senator Marklein is now Chair of the Revenue/ Financial Institutions and Rural Issues and Vice-chair of the Transportation and Veterans Affairs Committees.

#### 10. CONTRACTS

Quamme presented a contract for 2017 Visitor Guide Ad Sales for consideration. Evy Nerbonne is the sales person that has been selected. Contract reviewed, 20% commission for paid ads.

MSC Galasinski/Smith to approve a Contract to retain Evy Nerbonne to sell ads.

Quamme presented a Contract between the MRRPC and our WIMRPC to secure the planning services of the MMRPC to update the WIMRPC Corridor Management Plan for a cost not to exceed \$7000. This Plan updating will occur in the period between November 2016 and March 30, 2018.

Quamme also presented a contract between the MRRPC and our WIMRPC to secure the MRRPC planning services to develop a Commissioner's Handbook for a cost of \$1200. This work is to be completed between November 2016 and December 2017.

MSC Galasinski/Lorenz to approve these Contracts.

## 11. FRIENDS OF THE GREAT RIVER ROAD

Quamme reported that now that the By-laws for the Friends Group have been approved the next steps will be to hold public meetings, develop a membership and begin fund raising campaign.

## 12. WIMRPC BYLAWS Revision, present/approve

Galasinski presented the latest draft of the revised Commission Bylaws which included those changes to the August 5th Draft that were provided earlier by Commissioners.

These changes included the addition of a section relating to the relationship between the WIMRPC and the Friends of the WI Byway.

After discussion, MSC Donath/Smith to approve the Draft Bylaws as prepared and presented by Galasinski with some changes in grammar.

## 13. MRPC NATCHEZ SEPTEMBER 14-16

Quamme, Miller, Donath, Smith and Lorenz attended the 2016 MRPC Annual Meeting in this historic Mississippi River Town

In this year of 2016, Natchez is celebrating their 300th Anniversary as the oldest continuing settlement on the Mississippi River.

Some highlights from this meeting included:

The Cultural and Heritage Committee recommended 2 new Interpretive Centers which received MRPC Board Approval.

The Transportation and Marketing Committees both requested that the MRPC Board allocate up to \$35,000 of reserve funds to complete the GIS Navigation Mapping of the GRRNSB. The Board will consider this request at their December 9<sup>th</sup> Meeting.

## 14. MARKETING AND PROMOTION

The schedule for the sale of advertising and production of the 2017 Visitor Guide was reviewed. It is anticipated that the 2017 Guide will be available in early 2017.

The WIMRPC Web Site rebuild is progressing and is expected to be completed in early 2017.

The Committee discussed the 2017 Marketing Plan and 2017 Budget at their August and September Meetings. Items for consideration for the 2017 Budget include: Establish Photo Library with possible JEM

Grant (need photos for the southern half of GRRNSB), possible funds to retain Drone Services for photos, funds for annual hosting of web site, funds for the sale of Visitor Guide Ads.

A Social Media Policy has been developed by the Committee with Megan Berg of the La Crosse County C&VB as the editor.

## 15. NATIONAL SCENIC BYWAY PROGRAM PROJECTS/GRANTS-STATUS REPORTS

#### \*FY 10 - Genoa Fish Hatchery

Lorenz and Donath met meeting with Hatchery Manager Aloisi, F&WL staff and consultant in April to discuss how the GRRNSB is being included in the design of the GRRNSB Interpretive Center Exhibits. At that meeting, signing, the use of the GRR/NSB Logos, display areas, etc. were discussed and agreed upon. Donath and Lorenz will coordinate with F&WL Hatchery during this construction stage

Aloisi reported on November 10<sup>th</sup> that the outside stonework is being completed and all paving and exterior glasswork has been installed. Display design is still being developed. The main building is planned for completion by the fall of 2017

## \* FY 09 - Agritourism

Lorenz reported that \$1316 remains in this NSB Grant. The Promotion Committee will decide how to utilize the remaining funds An Agritourism Ad in the 2017 Visitor Guide is one option being considered.

## \* FY 08 - Building and Maintaining a Sustainable Byway Organization

Lorenz reported that to date we have utilized \$11225 NSB funds (\$25000 Grant amount) and \$1508 WIMRPC funds. Recent billings have been for Legal Work to establish a "Friends of the WI GRR" including services to create Bylaws and Articles of Incorporation.

The finds to complete the update of the CMP will be part of the Grant. This is also the case for the Handbook Contract.

#### \* Intrinsic Qualities

Lorenz reported that recent charges of \$364 that have been submitted to WIDOT for Rack Card design. We are awaiting for WIDOT reimbursement. After receiving WIDOT payment, \$4224 will remain in this NSB project.

## \* National Geographic Geo-Tourism Project

This NG Web Site is essentially complete however the nomination process will remain open through 2016. A meeting was held in New Orleans to review those nominations received to date.

The nomination forms for all WI Interpretation Centers have been submitted.

States are asked to develop an overall Management Plan for monitoring and updating the NG Site.

#### 16. WIMRPC COMMITTEE REPORTS

## **Partnership and Outreach Committee**

The Committee is recommending the development of an "Overall Action Plan" to better acquaint the Commissioners and Committee Members with the GRR Corridor. A tour of the Corridor is also a recommendation.

#### \*Capitol Rotunda Exhibit

The GRRNSB Exhibit was in place from Monday, 6/6/16 –Monday, 6/13/16 was a success A special thanks to Rep.Nerison and

Staff for their assistance. This is a high traffic week since school tours are taking place plus the Cows on the Concourse event is also this week. It was decided that the same week in in June 2017 should be reserved for the WIMRPC Exhibit.

#### \*Finance/Sustainability

Lorenz thanked all County Commissioners for contacting their respective County Boards with 2017 Budget Requests. Lorenz reported that La Crosse County had budgeted \$3000 and Vernon \$2000 and Quamme reported Crawford County had budgeted \$1000,

A grant for Grant County must be prepared and submitted by January 1<sup>st</sup>. Quamme with the assistance of Vondrum will develop.

The Chairs of the Promotion/Marketing, Partnership/Outreach/ Financial/Sustainability should submit their 2017 Budget Requests by December 14<sup>th</sup> so a Draft 2017 Budget can be reviewed and Approved at the January 13<sup>th</sup> Commission meeting.

#### \*Legislative Meeting Schedule

We will plan to meet with our 4 Legislative Commissioners in 2017 on February 7<sup>th</sup> pm at the State Capitol in Madison. Sen. Marklein's and Rep. Nerison's staffs will help coordinate.

Lorenz will circulate a Draft Agenda for comment prior to this meeting.

#### 17. MISCELLANEOUS

#### \*CAP X 2020 and Badger Coulee Line

.The CAPX 2020 line is experiencing some electrical interference with the BNSF Railroad signals between Cochran and Alma where 161 hwy Line is attached to the same towers. Work to correct this problem may not be completed until the spring of 2017.

The \$580m Badger-Coulee Line Project is in the right-of-way acquisition stage proceeding from South (Madison to the North (Holmen). This new transmission line will cross the GRRNSB near the interchange of STH 35 and USH 53and run parallel to the CAPX 2020 Line to the Briggs Road Substation.

There are 7 CAPX 2020 mitigation projects ongoing in Buffalo County worth a total of \$607,000 with a match ranging from 1:1 to 10-1. Main projects include the Buffalo County Courthouse Boiler, a trout stream rehab and prairie bluff restoration.

Galasinski reported that there is presently a CAPX 2020 mitigation project in progress for the Trempealeau Wildlife Refuge for a Wonder Learning Center for \$450,000.

#### \*Frac Sand

No current action in WI to report. Allamakee County in Iowa is completing a study on mining siting funded in part with MRPC Foundation Funds.

#### \*File Material for Repository

Lorenz reported that there has not significant progress on creating a WIMRPC repository pending a decision on format—hard copy or electronic and location. Materials received from Beekman's records are being temporarily stored in Viroqua at the Vernon County Economic Development Office.

2016 Visitor Guide storage is at La Crosse Graphics and at Pepin's Laura Ingram Wilder Museum. Will plan to use the same storage in 2017

Also the status of future storage at the proposed La Crosse C&VB is still uncertain due to merger of the La Crosse and Onalaska Tourism Offices at a new yet undetermined site.

## La Crosse, Rose Street Project

Lorenz reported that the City of La Crosse has contracted with a Design Consultant to prepare a 20-year Corridor Master Plan for roadside development along the USH 53 Corridor from I90, Exit 3 southerly to La Crosse Street. The City and their Consultant have been involving local citizens, businesses and stakeholders and agencies in this planning effort. Lorenz has been in contact with Jason Gilman, Director of City Planning and indicated that the WIMRPC would like to provide input concerning the importance of the route being the GRRNSB.

## 9. WI DOT UPDATE

Francis Schelfhout, WIDOT Technical Committee member, provided details on the Trail Project between the Trempealeau Refuge (Marshland) and the City of Winona. This project is being funded through the WIDOT program with trail construction including a new bridge over the BNSF Railroad and a new deck in the bridge over the Latsch Island Slough. Buffalo County is the local sponsor for this Project.

Schelfhout handed out lists of the scheduled projects on the GRRNSB between Prescott and the WI River and answered questions concerning these Projects. He will provide project date for Grant County at a later date.

## 6) PUBLIC MEETING, TRAINING VIDEO (advanced in the Agenda)

Tom Kratt, WIDOT, in place of Francis Schelfhout, presented a 15 minute video entitled "Wisconsin Public Records Law"... Kratt also provided a 12 page handout which included all of the information included in the video concerning the open meeting and open records laws, public records responsibilities, record retention and public requests.

In that the WIMRPC is a quasi-government organization we must conform to this Public Records Law, Quamme appointed Lorenz, Schelfhout and Paoni to develop a draft procedure for WIMRPC to be presented for approval at the November 10<sup>th</sup> WIMRPC Meeting.

#### .3. MINUTES:

The minutes of May 5, 2017 meeting were reviewed and approved. MSC; Galasinski/Smith.

## 4. TREASURER'S REPORT

Acting Co-Treasurer Quamme reported that there is presently (8/4/17) a balance of \$33025.62 in the Commission's Checking/Savings Account. This amount includes revenue from past and present Visitor Guide sales and WIMRPC Reserve funds.

Quamme then reviewed a number of QuickBooks Reports ----Balance Sheet of August 4, 2017, Profit and Loss January through August 2017 and the Customer Balance Summary through August 4, 2017.

All invoices for the 2017 Visitor Guide have been paid. There are still several for the 2016 guide that remain unpaid and may need to be written off.

MSC Smith/Galasinski to accept the Treasurers Report.

An audit of the Commission's financial records will be delayed until a Commissioner is appointed to assist Tom Vondrum.

Mulry reported that the State of MN has approved a Budget Item to fund the MNMRPC for another 2 years.

## **6. DRAFT HANDBOOK**

Fletcher and Smith discussed the completed version of the Commissioner's Handbook. It was decided that 40 hard copies in binder form would be produced and then provided for Commissioners and Committee members. An electronic version would be provided to the other MRPC States. The WI GRR map file will be received 8/15/17 and will be included.

#### 7. CORRIDOR MANAGEMENT PLAN

Fletcher reported that all "rating sheets of State and Community owned public facilities" have been completed by each Commissioner for their area and this information will be used to assess the condition and needed improvements of the Visitor Facilities. .

An amended Consultant Services Agreement with CS Corridor Solutions for \$7800 was reviewed and approved-- MSC Lorenz/Galasinski. Part of the expense will be paid from the Building & Maintaining a NSB Grant. An additional up to \$5000 is needed to fund this project. MSC Smith/Galasinski to amend the Administrative Budget by this amount.

Key Stakeholders Meetings will be held in La Crosse and possibly other locations by early fall. The names and email addresses of potential invitees are needed by Aug. 30, 2017. Email S. Quamme with the list of Key Stakeholders in each County including public officials, organizations, and WI GRR businesses should be included.

A combined CMP will be prepared by CS and the MRRPC.

## 8. DREDGING OF MISSISSIPPI IN POOL 4

The comment period for the dredging and on land storage of an estimated 10 million cubic yards of material from Pool 4 has been extended until August 25 due to the large number of concerns expressed by the public and agencies.

Quamme provided copies of letters including Department of Agriculture Secretary Brancel who expressed concern about the loss of farmland and from WIDOT wherein they expressed concern about Scenic Easements, traffic impacts and access approvals. MSC Nerison, Galasinski for Quamme to prepare a letter from the WIMRPC to the COE by August 25 expressing the WIMRPC concerns.

Mulry reported that there was a very large attendance at the COE Public Meeting in Wabasha, MN who voiced opposition to the proposed location of dredge spoils in that area.

## 9. LEGISLATIVE UPDATE, STATE BUDGET PROCESS, TRANSPORTATION and SS14.85

Nerison, Shilling and Prange reported that the Legislature is still in negotiations concerning the 2017-2019 State Budget especially with concerns about the Transportation and Education areas.

The FOXCONN Project has added a significant amount of discussion and controversy.

The significant negative impact on Tourism of the Railroad Trespass Law has built support to draft a new Bill to allow the public to cross to other public lands and the River per Rep. Nerison.

SS 14.85--Prange reported that contacts have been made with the Department of Agriculture and WEDA about Ex-officio membership and the assignment of Technical Members to the Commission. Both agencies expressed agreement.

## 10. MONARCH HABITAT

Donath has been providing information on the creation of monarch butterfly habitat/waystations to help in the recovery of this species .Kits are available with seed packs for those schools and individuals that are interested.

A number of waystations sites along the GRRNSB have been developed by schools and individuals.

## 11. GENOA FISH HATCHERY

Donath has been in contact with Hatchery Manager Doug Aloisi on the construction status of the Interpretive Center. A Grand Opening has now been delayed until spring of 2018. A draft of the exhibits is now being reviewed by Donath, Quamme and Lorenz.

## 12. NATIONAL SCENIC BYWAY PROGRAM PROJECTS/GRANTS-STATUS REPORTS

## \* FY 09 - Agritourism

Lorenz reported that \$1316 remains in this NSB Grant. The Promotion/Marketing Committee will decide how to utilize the remaining funds. Updating the new website with Agritourism opportunities is one option being considered. The Committee will plan to utilize these remaining funds in 2017.

## . \* FY 08 - Building and Maintaining a Sustainable Byway Organization

Lorenz reported that \$12,763 remains in this project. To date we have utilized \$11225 NSB funds (\$25000 Grant amount) and \$1508 WIMRPC funds. 2016 billings for Legal Work to establish a "Friends of the WI GRR" including services to create Bylaws and Articles of Incorporation. That work is completed. A computer, printer and software have been approved by Jane Carrola and need to be purchased from this grant.

The funds to complete the update of the CMP will be part of the Grant. This is also the case for the Handbook Contract with the MRRPC.

#### \* Intrinsic Qualities

Lorenz reported that recent charges of \$364 that have been submitted to WIDOT for Rack Card design. We are awaiting for WIDOT reimbursement. After receiving the WIDOT payment, \$4224 will remain in this NSB project.

#### 13. PROMOTION/ MARKETING COMMITTEE

Gabay asked the Commission to approve contracting with Phillip Wanke and Julie Wanke to sell advertising along the GRRNSB for the 2018 Visitor Guide.as recommended by the P/M Committee. MSC Galasinski/ Prange

A letter will be sent to past advertisers to determine their interest in the new Guide and this information will be sent to Julie and to Philip Wanke by September 1<sup>st</sup>. It is intended that an increased number of advertisers will be secured resulting in a larger edition of the Guide.

The new WIMRPC Web Site rebuild is progressing on schedule. Please review and let Amy know what might be missing? Gabay will send us a form for getting businesses included in the Web Site.

An intern from UW-La Crosse has been used to help secure more photos along the GRRNSB South

A big thank you to Commissioner Tom Vondrum for staffing the State Fair booth and handing out Visitor Guides with Dept. of Tourism and also thank you to Karen Dahl and Vernon County Tourism Council for giving out our Visitor Guides at their booth.

The Intrinsic Qualities Rack cards have been printed and are available for distribution. 6 sets of each rack card was distributed to those present, Commissioners are to supply them to interpretive centers, schools and interested businesses.

## 14. MRPC ANNUAL MEETING IN MARQUETTE, IA

Quamme encouraged members to attend the MRPC Annual Meeting, Marquette, IA September 19-21. The Meeting Theme is "lowa's Driftless Area" and a number of tours on land and water are planned.

The Welcome Reception will be held at the new Driftless Area Education and Visitor Center at Lansing IA. WIMRPC submitted a nomination for the National Stewardship Award to be presented 9/21/17 at the MRPC Conference.

## 15. NOMINATION COMMITTEE FOR NOVEMBER ELECTION OF OFFICERS

Quamme appointed Donath and Smith to be the Nominating Committee to provide a list of WIMRPC officers for the November 10<sup>th</sup> WIMRPC Meeting.

## 16. OTHER BUSINESS

Quamme appointed Lepke to the Finance Committee and Smith to Chair the Education Committee.

The Annual Meeting of the Friends Group is scheduled immediately following the close of this meeting.
