Mississippi River Trail (MRT)

- Presented materials (Appendix A)
- Trademark
 - Established in 1996 MRT, Inc. TN Non-Profit
 - Established with previous members/board members that MRT, Inc. defunct.
 - Trademark not currently secured.
 - TN to pursue options (non-legal)
 - WI to pursue options (legal) if necessary, on behalf of MRPC
 - Trademark Legal Fund = \$1,500
 - Transportation Committee Annual Budget is \$500
 - C & H dedicated their annual budget at Board Mtg 9/20/23.
 - ERA dedicated their annual budget at Board Mtg 9/20/23.
- Sign Plate
 - The signs/image covered under the Trademark are in existence in all 10-states (substantially less in WI and IL)
 - M1-9 modified US Bike Route sign plate interim approval under old version of MUTCD but was not an "in perpetuity" approval.
 - New requests for sign plate approvals would be coordinated with the FHWA representatives from each state/region covering the 10-State

MRPC

- Options in order of preference:
 - Secure Trademark followed by 10-State request to continue to use/maintain the previous sign plate – request "in perpetuity."
 - Secure Trademark followed by 10-State request to use existing US Bike Route sign plate with "MRT" vs. a number on the sign plate.
 - No Trademark secured embrace US Bike Route 45 (currently planned route – along Mississippi River)
- Designation 3 Step Process US Bike Route AASHTO
 - Draft Route
 - Google search for MRT and existing signage establishes the existing route in all 10-states.
 - MRT substantially follows the GRR, but consideration for alternative routes should be given where parallel, less busy routes or alternative facilities (paths, trails, bike lanes, etc.) exist now that previously did not.
 - Frequently in or near Cities/Villages
 - Regional/Local routes/trails should be overlaid where appropriate for mutual benefit (funding/marketing)
 - Both Existing, Alternatives, Proposed Routes can be built (KMZs created) in Google Maps – Francis will build "How to" document for next Committee Meeting
 - Local Agreements/Support
 - This will be the "heavy lift" when it comes to time and resources.
 - WI: 66 Cities/Villages/Towns + 8 Counties
 - KY: 3 Cities + 4 Counties
 - TN: 5 Counties
 - MN: Complete but confirmed this was where the effort is required.
 - State DOT's Bike/Ped Coordinators would be best contacts/presenters of this effort.
 - Submit Application (followed by signage)
 - 10-State Application All in this together
 - AASHTO application requires letter/resolution of support from every municipality that the MRT runs through (regardless of roadway jurisdiction – i.e. State highway through a Township, still need Township letter/resolution)
 - Signage efforts should follow approval of US Bike Route
 - Maintenance of signs should be discussed encourage DOT responsibility as US Bike Route

 - Create "How To" document begin with mapping your route in GoogleMaps

Interpretive Centers – Wayfinding Signage

- Wayfinding signage inventory (including pictures) to ICs.
 - Emily and Francis creating a working document (Appendix B)
 - Baseline Signage Standards Categories:
 - On/Visually available from GRR or visually available after you turn off the GRR
 - WI has 4 sign minimum (2 each direction) 1 ahead, 1 at/turn
 - IA has 2 sign minimum (1 each direction) 1 at/turn (no ahead)
 - Could there be a minimum and desirable signing standard for each category?
 - Off 1 along same road that you turn off the GRR.
 - Off 2 a distance great enough to possibly warrant reassurance but along same road.
 - Off 3 multiple turns or off so great a distance
 - No signage To far from GRR or "for profit" organization/site
 - Establish Existing Conditions/Inventory anyone can do this using Google Maps/Earth
 - Inventory completed in WI reports available for examples, includes:
 - Parcel maps overall site picture (access points, parking, etc.)
 - Google Maps directions shows main highways, provides directions/turns, also provides likely path of travel from north/south.
 - GIS Map and/or inventory provides latitude/longitude, location, age, condition, etc. (this will likely vary from state to state)
 - Picture inventory this can be gathered from Google Maps/Earth
 - Spreadsheet inventory completed in IA (Emily Whaley)
 - Establish Baseline Signage Category per IC this should be a discussion with the state MRPC, state DOT and the IC
 - Maintenance Plan/Agreement
 - There must be a benefit to the IC "What's in it for them?"
 - Maintenance who is responsible for replacement (this may be multiple jurisdictions), but who is responsible for reporting damage, wear, stolen, etc.?
 - Would like ICs to report on signs on some regularity annually or biennially with checklists?
 - This would hold the MRPC accountable to "supporting" our ICs that are required to have MRPC/GRR signage within their sites.
- ACTION ITEMS:
 - Create "How To" document begin with parcel maps.

- Was not requested or "grand-fathered in" when the new MUTCD was published
- Actions Next Steps
 - Without Trademark ownership or permission to use, we should not move forward with this
 - Petition to FHWA for either another interim approval or a perpetual approval
 - MRPC National Office National Letterhead 10-State Support 10-States in a different status (Designated, Signed or Both)
 - Who (committee) leads this effort?
 - Who (committee) supports this effort?
 - How might a committee support this effort?
 - Vehicle and Trail size signage interim approval should be sought as part of this request

Route Status (per State should be established):

- Designated:
 - Drafting the Route
 - Draft Routes between neighboring Mississippi River States
 - Securing Local Agreements along the Route
 - Preparing and Submitting the AASHTO Application (see Actions Next Steps)
- Signed:
 - Level of Signage
 - At Turns ("ahead" and "here")
 - Reassurance (within long sections without turns)
 - Signage Condition
 - Range of installation age

<u>Interpretive Center Signs – Establishing Baseline Signage</u> <u>Standards</u>

Categories:

- On/Visually available from GRR or visually available after you turn off the GRR
- Off 1 along same road that you turn off the GRR
- Off 2 a distance great enough to possibly warrant reassurance but along same road
- Off 3 multiple turns or off so great a distance
- Others?
- Is there ever a "No signing" category?

Category Baseline Signage:

- On: "Ahead" and "At"/"Turn" signs from both directions
- Off 1 Additional "At" sign
- Off 2 Additional "Reassurance" signs as appropriate
- Off 3 Additional "Ahead" and "At"/"Turn" sign per additional turn (single direction) with additional "Reassurance" signs as appropriate

Workflow:

- Existing Conditions: provide inventory (Departments)
- Establish Baseline Signage based on Categories (MRPC/States/ICs)
- Maintenance Plan/Agreement (Workflow probably at the IC level, within the state)

Considerations:

- Multiple signing jurisdictions (standards/sizes/name/install/maintenance)
- Simplicity of all levels of documentation (Department to Public to IC)
- ICs with large acreage or multiple entrances or both
- MUTCD Restrictions on Recreational/Cultural Signs
 - Section 2M.09 Destination Guide Signs
 - May be posted at intersection/crossroads to access or road to access
 - May be posted as supplemental guidance signs to direct road users to the destination
 - Where access/crossroad leads exclusively to the destination, guide sign and exit direction sign may be posted
 - Did not find any distance restrictions but logic should probably be applied
- Business vs. Non-Profit (Brewery vs. Brewery Museum)
- IC could be in two categories depending on GRR direction of travel (if off GRR)
