Describe the history of involvement of the nominee in issues relating to the Great River Road, the Mississippi River, or a river community.

Roz has been instrumental in her work with Sabrina Chandler and Chris Stein to create training programs and website available pollinator habitat resources for anyone wanting to create pollinator habitat. She has created "how-to" documents, brochures, fliers about creating pollinator habitat for a multitude of age categories which are easily understood and show what to do on any scale. The National Mississippi River Parkway Commission has been a very early leader organization in the efforts to positively impact improving the habitat for monarch butterflies and other pollinators. Roz authored the National Pollinator Habitat Kit - How to Do It document, created the brochure that accompanies this document and made it available on the Rotary International website, MRPC website and others that are shared along with our 10 State Members. In addition, she financially supported author Nick Nichols in his work to create and illustrate the book for 8 year-olds, soon to be released, "The Pollinator Parade". Roz is a active member of the MRPC ERA Committee who has contributed her information on pollinators at our past 3 annual conferences. She has organized and participated in webinars featuring pollinator information which began during the Covid-19 months.
