• MRT STATUS:

- Trademark for MRT/Mississippi River Trail currently owned by MRT, Inc. will expire in March 2025. Legal action will be taken at the national level and at individual state levels as necessary or deemed appropriate to secure this trademark on behalf of the 10-State MRPC.
- N.O. is in the process of developing the 2025 Budget and based upon estimates from the attorney that is currently advising on this effort the request for a not-to-exceed \$5,000 line item for legal services will be requested on behalf of the Transportation Committee.
- WI MRT effort is nearing completion with all resolutions necessary for a US Bike Route application being attained by Spring 2025. Due to biennial budget cycle in WI, it is more likely that actual signage of the route would occur in 2026. If other states were interested in completing the resolution and formal designation process in advance of that timeframe, WI would entertain holding off so that a multi-state application could be submitted to AASHTO/Adventure Cycling for US Bike Route Designation.
- Creating a work group, similar to the AAR effort, with DOT Bike/Ped Coordinators as the primary contacts was recommended – development of that list of contacts by each state should be pursued.
